NOTICE INVITING BID ("NIB")**1.0 INTRODUCTION**

1.1 ONGC Tripura Power Company Limited (hereinafter referred as "**OTPC**" or "**Owner**"), a joint venture company promoted by Oil and Natural Gas Corporation Limited ("**ONGC**"), Infrastructure Leasing and Financial Services Limited ("**IL&FS**") and Government of Tripura, is a public limited company incorporated under the Indian Companies Act, 1956 and having its registered office at ONGC Tripura Assets, Badarghat Complex, Agartala, Tripura-799014 (India), and one of its office at 6th Floor, IFCI Tower, 61, Nehru Place, New Delhi-110019 (India). OTPC is setting up a 2 x 363.3 MW combined cycle power project at Palatana, which is about 60 (sixty) km from the capital city of Agartala in the State of Tripura. The Site where the Project is being developed is located about 9 (nine) km from nearest town Udaipur.

1.2 OTPC invites domestic Bidders with requisite technical capability and sound financial position, for LSTK (Lump Sum Turnkey) bids for Re-Construction of BHEL Store - 3 RCC Flooring of OTPC, Palatana,Udaipur gomati Tripura at 2 x 363.3 MW combined cycle power plant, located at Palatana, Udaipur (Tripura).

1.3 The Bid must be submitted in accordance with the requirements set out in the Bidding Document, in a sealed envelope containing 2 (two) separate sealed envelopes:

1.3.1 The first envelope will have qualifying experience/capability and Unpriced Techno-Commercial Bid without any reference to price; and

1.3.2 The second envelope will have the Price Bid for Re-Construction of BHEL Store - 3 RCC Flooring of OTPC, Palatana,Udaipur Gomati Tripura.

3.0 BRIEF SCOPE OF WORK

- 1.3.4 The brief scope of work to be performed under the Bidding Document shall include Providing for Re-Construction of BHEL Store - 3 RCC Flooring of OTPC, Palatana,Udaipur Gomati Tripura at 2 x 363.3 MW Combined Cycle Power plant at Palatana, Tripura.

4.0 QUALIFICATION REQUIREMENT OF THE BIDDER

As per Tender Pre-Qualification Criteria for Bidders for Providing of Re-Construction of BHEL Store - 3 RCC Flooring of OTPC, Palatana,Udaipur Gomati Tripura.

5.0 GENERAL

- 5.1 On the basis of a written application, Bidding Document can be purchased from the office of the DGM(Projects), OTPC, Palatana Project Site, Udaipur, Gomti District, Tripura – 799105 on working days as per the price and other payment details indicated above in Article 2.0.
- 5.2 Bidders to confirm compliance to terms, conditions, specifications and requirements mentioned under the Bidding Document, at the time of submission of Bids, failing which the Bids may be liable for rejection.
- 5.3 Bids shall be evaluated based on the information/documents submitted in the Bid. Hence, Bidders are advised to ensure that they submit appropriate and relevant supporting documentation along with their proposal in the first instance itself.
- 5.4 OTPC reserves the right to seek additional information from the Bidders, if found necessary during the course of evaluation of the Bids.

- 5.5 Bidder to ensure that after the Letter of Award is issued and during the term of the Contracts, the Bidder shall not seek to alter any agreed contractual terms, conditions and specifications as mentioned under the Bidding Document.
- 5.6 Two part bidding system (Part-1: Unpriced Techno-Commercial Bid and Part-2: Price Bid) are invited from 3(three) years experienced (total of all work orders) in providing housekeeping and catering services in the offices /Plants/ Guest Houses/Hostels of Government Organizations/Semi Government Organizations/PSU/other reputed Public Limited Company . Bidders should take due care to submit their Bid in accordance with the checklist for bid submission and duly Accepted & signed standard GCC, SCC & Technical Specification of the bid.
- 5.7 This NIB, in original, issued along with Bidding Document, shall be submitted by the Bidder along with its Bid duly signed and stamped by the Bidder as a token of acceptance. Bids sent without having the original copy of the Bidding Document duly signed and stamped may be liable for rejection.
- 5.8 Issuance of the Bidding Document does not mean that the Bidder has been short-listed or qualified.
- 5.9 Bidders are required to furnish an undertaking on validity of the Bid as per **Form-K** of the Bid Forms at the time of submission of Bids. The Bids shall be rejected if such an undertaking is not furnished.
- 5.10 Bid Security (EMD) must be submitted as part of the Unpriced Techno-Commercial Bid in form of DD. Bid shall be rejected without EMD.
- 5.11 Any Bid received after the expiry of the date and time prescribed for receiving completed Bid as specified in Article 2.0 above, shall be rejected.
- 5.12 OTPC reserves the right to reject any / or all of the bids received at its discretion, without assigning any reasons whatsoever.
- 5.13 OTPC is not bound to accept the lowest Price Bid.
